



the costs associated with starting and pursuing a lawsuit against a license bond are borne by the contractor's license, not the homeowner. the recovery fund exists to provide a means of compensating homeowners who are not satisfied with the value of their home and the workmanship of their contractor. the funds provided by the recovery fund are not insured. they are paid from a statutory fund maintained by the registrar of contractors and are treated as a trust fund. the registrar is not a party to the lawsuit and is not responsible for the funds that it distributes. in a lawsuit, the claimant must prove that the contractor was licensed at the time the work was performed. the claimant must prove not only that the contractor was unlicensed when the work was done, but also that the claimant suffered damages as a result of the unlicensed contractor's acts. if the claimant wins a lawsuit against the contractor's bond, the court may award both compensatory and punitive damages. the recovery can include damages for physical injury to property, emotional distress and pain and suffering. (1) any contractor licensed under a.r.s. 32-1101 through 32-1185, inclusive, who performs services in the state, either as principal or as an agent of another, including, but not limited to, performing any of the following: after scanning, you can preview the files that you are going to recover. you can preview the file structure and file name, as well as the file content. press the restore files button to recover the selected files.

the contractor is guaranteed the right to due process under the statutes and constitution in any legal proceeding, if a hearing took place in the underlying complaint process, it was for disciplinary purposes, please keep in mind that the disciplinary legal process is wholly separate and apart from any proceedings necessary to resolve a recovery fund claim. recoverit data recovery is a free file recovery software; it is the best alternative file recovery software to recover my files. it is a professional data recovery software; the software supported windows and mac system, recover more than 1000+ file formats, no matter what caused your data lost and where your lost data stored. it can easily and quickly recover deleted files from the computer , recover deleted files from hard drive, usb drive, memory card, or other storage devices. pursuant to a.r.s. 32-1133(b), the claimant (plaintiff) must notify the registrar of the commencement of the lawsuit, the plaintiff must also submit a copy of the relevant court filings and all required supporting documentation to establish eligibility and damages, as explained above and including proof showing a claim on the contractor's license bond has been fully processed. you must be licensed in order to file a complaint. if you do not have a license, the complaint will not be valid and no license will be issued for the case. you must file your complaint with the registrar's office within the time frames set forth in the code. a.r.s. 32-1132.01(b) complaints not made within the timeframes stated above may be dismissed. the contractor is not entitled to file any subsequent claim for damages with the registrar or recover any funds previously paid by the department of economic security.
